

Advertisement for Engagement of Advisor in

India Infrastructure Finance Company Limited (IIFCL)

IIFCL is a wholly owned Government of India Enterprise. IIFCL is providing long term financial assistance to various viable infrastructure projects in the country.

The Company renders long term financial assistance to infrastructure projects including roads, railways, seaports, airports, inland waterways, power, urban infrastructure, gas pipelines, SEZs, warehouses, cold storage chain and Tourism. The Company raises long term resources from Domestic market, bilateral and multilateral agencies such as JBIC, KfW, ADB & World Bank.

IIFCL intends to engage an Advisor on contract basis for a limited tenure of upto six months which can further be renewed at sole discretion of IIFCL, with the overall tenure not exceeding 12 months.

Qualification	Graduate Degree + Professional qualification in Banking
Experience	Over 25 years in the financial / banking sector
Previous Positions held	Ex- Whole Time Directors/CMDs of Public Sector Banks/All India Financial Institutions.
Age	The applicant should not have attained the age of 65 years as on 31 st January, 2018. However, the upper age limit may be relaxed by the Competent Authority by two years i.e. upto 67 years for deserving candidates.
Tenure	Upto six months. This may further be extended by another six months at sole discretion of IIFCL, with the overall tenure not exceeding 12 months.
Remuneration	Remuneration will be negotiable in line with the prevalent market rate.

2. Key Objective and Responsibilities:

- Advise on various issues pertaining to the Management of Credit, Market and Operational Risks and other Credit related matters of IIFCL pertaining to Infrastructure Sector.
- Advise on various aspects pertaining to Monitoring Loan Accounts, Restructuring, NPA-Management, and Recovery including expert advisory support in external meetings including representational responsibilities.
- Advice/quality assure efforts towards Business Development and Product Structuring for Infrastructure Sector in IIFCL
- Advise on matters relating to Treasury and Investment functions.
- Any other task as identified by IIFCL.
- Expected to be available for at least seven days in a month at the Head Quarter.
